FIRST ANNUAL ART SHOW - Brightwaters, NY

DATE: Sunday July 29, 2007 - 9 AM to 5 PM - (Artist Space Agreement due May 31, 2007)

LOCATION: Windsor Fields, S/W Corner of Montauk Highway & Windsor Ave, Brightwaters, NY

SPACE SIZE: Approximately 12ft x 12ft : Artists will sell from their assigned space, and spaces are assigned in the order the **Artist Space Agreements** are postmarked. Artists will supply their own tents, easels, tables, chairs and any additional material to make their display as attractive as possible. The artist will be responsible for maintaining their area neat and clean at all times during the show. A diagram of the show area is on our website at www.brightwaters.org/artshowmap. SPACE FEE: \$45.00 NON- REFUNDABLE: Payable to Brightwaters Involvement Group. Due June 15, 2007.

PARKING: There are a limited number of parking spaces for exhibiting artists at the back of the show area, available on a first come first served basis. Cars will only be permitted to enter Show Area for unloading and must be promptly removed and parked. Any additional vehicles **MUST BE PARKED IN THE LIBRARY PARKING LOT** located diagonally across the street. **VEHICLES PARKED ON THE SIDE STREETS MAY BE REMOVED AT THE OWNERS EXPENSE!** Street parking is for patrons entering the show **ONLY**.

SET-UP: 6 AM. Artists must be set up and have booth ready one half hour (8:30AM) before the opening of the show.

NOTE: Supplies, boxes, etc. must be hidden from view. Electricity is not available. There may be **NO** signs advertising sales or special offers . **NO** packing or leaving the show before 5 PM.

Artist agrees at dealer's cost to indemnify, defend, and hold harmless the Village of Brightwaters, the Town of Islip, their agents and/or employees, chairman, coordinator, and representatives from and against any and all liabilities, claims, demands, expenses, fees, fines, penalties, suits, proceedings, actions and causes of action of any and every kind and nature arising or growing out of or in any way connected with artist use, occupancy or activities in the First Annual Art Show. Artist will be personally liable to other dealers and members of the Public for their own act of negligence.
